

ARTGALLERY AWARD 2010

First Edition

Art.1 - FINALITY

Artgallery Award is organized by the non-profit Association Artgallery. It promotes emerging artists, rewarding the winner with more visibility. The winning artist will have a personal exhibition in one of the most prestigious galleries or museums in Milan.

Art.2 – ELEGIBILITY

The competition is open to Italian and foreign artists aged between 18 and 40 years old.

Art.3 – TECHNIQUES ALLOWED

1. Painting: oil, acrylic, industrial paints, ink, vinyl, watercolour, graphite, pastels, prints of various kinds.

2. Digital Photography and Graphics: 2D pieces of work, including digital photography, analog photography, computer graphics, software art or work made with various techniques, such as digital manipulation (including the use of paint or other forms of manual expression), web art, polaroid, photos from phone, photo collages.

3. Installation & Sculpture: they must not be too bulky, their size must fit for exhibitions in museums or art galleries.

Art.4 - REGULATION

Artgallery Award is divided into 2 stages:

1) ONLINE CONTEST

It is an online pre-selection on www.associazioneartgallery.org. All participants should send one significant work only. An Internal Committee of the Artgallery Association will evaluate the works and will elect the 20 finalists. Quality, research, innovation and modernity are the basic standards for selection. The work sent must be the highest artistic expression of the participant. The candidate work can either be published or unpublished. The theme can range from figurative, abstract or conceptual.

2) FINALE

The 20 selected artists will have to submit additional pieces of work to the Association. These will be evaluated by a Scientific Committee composed of art critics, creative directors, members of the world of finance, representatives of museums, cultural associations and foundations. The assessment will take into account the expressive ability, technique and innovation of each work and artist.

Art.5 - AWARD

The winner will have a 15 days dedicated exhibition planned for June / July 2010, including the following:

1. A 50 pages catalogue
2. Promotion of the event in Milan
3. Press office
4. A trophy

Art. 6 TERMS OF PARTICIPATION

Log-in for registration to the site www.associazioneartgallery.org, go to the CONTEST section and fill in the form. After the registration you will have to upload:

- 1) a jpg image of your work not exceeding 2 MB. ☐
- 2) your CV and a short essay about your art (max 1000 characters) ☐
- 3) work description: title, technique, size, media used. ☐ You can submit one work only.

Art.7 - DEADLINES

The online contest expires on February, 1st 2010. All additional works must arrive no later than February 15, 2010.

Art.8 - ACCEPTANCE AND COPYRIGHT

(a) By signing the entry form online or by accepting the notice Artgallery Award 2010 - First edition, the artist agrees to all of the following:

(b) The Artists grants to Association Artgallery the rights to reproduce the works and texts needed to create the catalogue, store registrations and publicize the works on the Award website, or other forms of communication and activities of the Association.

(c) Any photographic material on paper or CD / DVD, the CV and all text submitted for participation will not be returned.

(d) The person or organization that performs the direct entry of the access on the site, is entirely responsible for the content of visual and textual material posted and transmitted on the site of the Award. The Association reserves the right to refuse images or text deemed offensive or defamatory.

(e) The candidate frees from any liability the Association for any misuse by third party of images of the works.

(f) The candidate authorizes the Association Artgallery and their direct representatives, to treat the artist's personal data in accordance with Law 675/96 ('Privacy Act'), as amended legislative decree no. 196/2003 (Privacy), also for inclusion in databases operated by the persons in question. Any dispute will be treated in Italy and under Italian law. Personal information and pictures of works may be used by the Association to promote other events of contemporary art, web promotion, communication and marketing. The e-mail of the artists participating in the Award will not be disclosed or sold to third parties.

(g) The Association reserves the right to make changes to this notice if and when needed.
